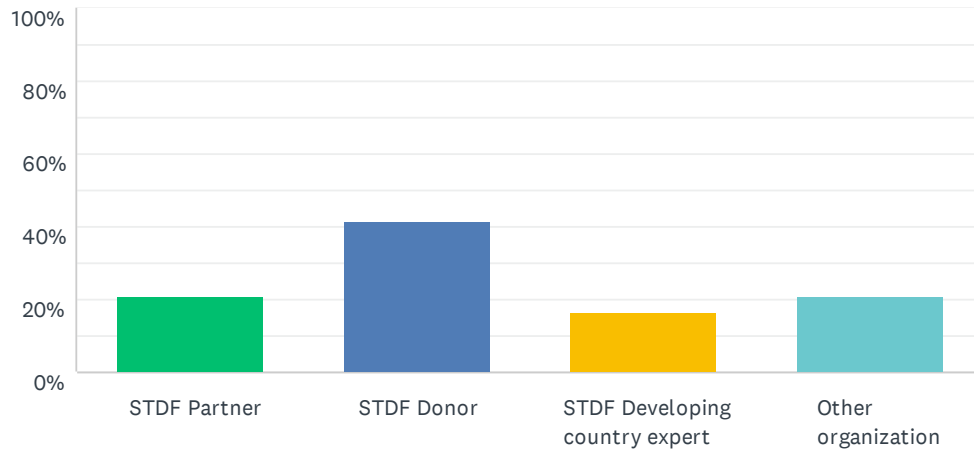


Q1 Please indicate who you represent:

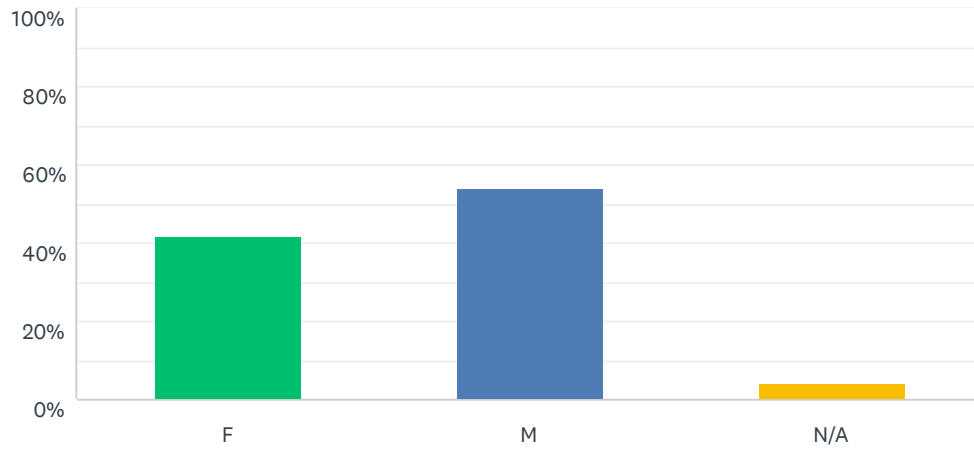

Q2 Please indicate your gender:

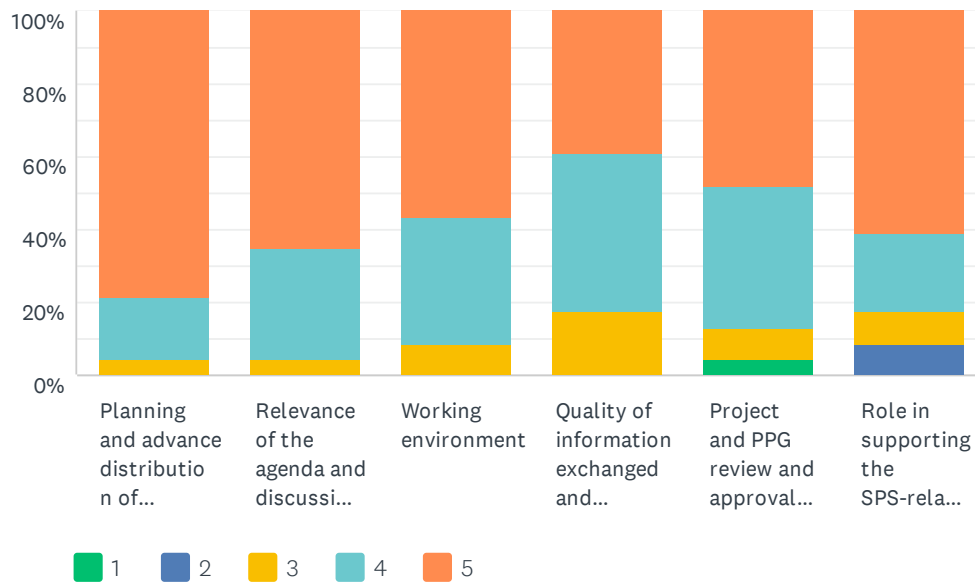

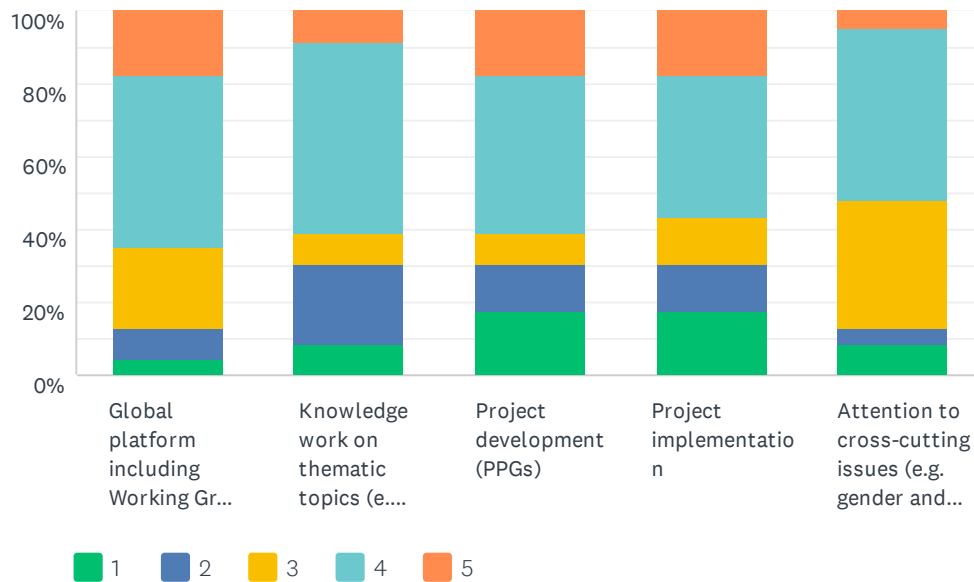

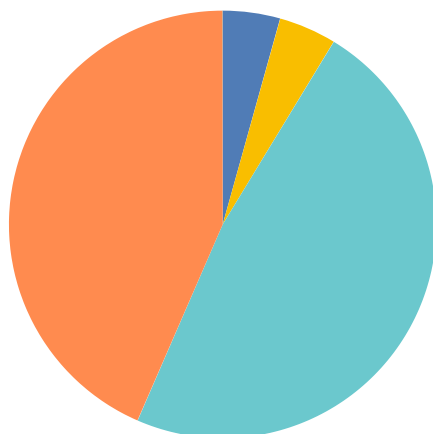
