	The visit had the objective of understanding how food safety regulators

development of policy papers with countries like Canada, as well as national and regional workshops to build capacity of officers and share experiences from different countries.

Johnson Ssubi updated on the progress of the vTPA project in Rwanda and Uganda, which also included the participation of regulators from the two countries in the learning visit to the UK FSA. He mentioned that the regulators also enhanced their knowledge but there is interest in having another benchmark where international vTPAs are used to have a deeper understanding. Johnson also spoke about some of the activities planned for next year including the development of a roadmap or strategic plan for the implementation of the vTPA approach.

## Trainings and capacity buildings

lain Lucey from GlobalG.A.P. presented the outcomes of the 2-day training provided in Mali thanks to the support of GlobalG.A.P. to the pilot project in West Africa. Around 70-75 participants from ministries, agencies like plant protection, national directorates of agriculture and industry, food safety practitioners and farmers learned about the key principles and functions for food safety and increased market access, implementation of good agricultural practices and the role of certification. On the second day, participants got the opportunity to visit a GlobalG.A.P. certified farm in the region. Participants were satisfied with the training, which also raised some key issues concerning adoption and local awareness and benefits of certification, as well as the lack of available auditors and certification bodies in Mali. Address the gaps before.

## Round table discussion

John Duffill shared how the SAFEGRO Project in Vietnam initiated a discussion about VietGAP and gave an introduction about the activities that are being organized for the project including a training for growers and producers. More information on the improvements to VietGAP for exports to international markets and the intervention plan for the project will be presented at the next meeting.

Two additional topics were discussed at the end of the meeting: remote audit and inspection, and auditor scarcity. In the same way that data generated by vTPA programs can help take certain decisions for regulators, such as for the inspection frequency, Gabor Molnar from UNIDO referred to the possibility of using information to decide if a country can conduct remote audit and inspection practices, as it is the case for Indonesia. He also mentioned that remote audit and inspection is already at level 5 in the discussions by regulators to be adopted by the Codex Alimentarius.

On the topic of auditor scarcity as it seems that there is no new generation coming with a required level for the global food industry to remain operation, Gabor Molnar informed the partners about a concept note that is under preparation to deal with the issue.

	Marlynne Hopper from the STDF thanked CFIA and GlobalG.A.P. for their contributions to the vTPA pilot projects. She also congratulated Daniela from IICA on all activities conducted and mentioned that prioritizing policy papers with options will be useful in the future. Marlynne also mentioned Land O'Lakes gender analysis on their project, commented on COMESA's work on financing to promote vTPA programmes.
